## Southern Shores Resident Cheats Death

### Roy Singletary survives a near fatal heart attack with the aid of two of Southern Shores' finest.

On April 30, 2011 at approximately 6:15 in the evening, Officers Tracy Mann and Eddie McKeever received a call of a subject in cardiac arrest at 153 High Dune Loop. Upon arrival, the officers were greeted by Sandra Singletary who took them to her husband, Roy, who was unconscious on the floor and not breathing. The officers quickly responded by performing CPR on Mr. Singletary with the aid of an AED (Automated External Defibrillator.) The officers continued to aid Mr. Singletary until Dare County EMS arrived a short time later.

Through the combined efforts of the Southern Shores Police Department, Southern Shores Volunteer Fire Department and Dare County EMS, Mr. Singletary was resuscitated and moved for transportation by Dare Med Flight to Norfolk, Virginia. The details of Mr. Singletary's hospital stay are unknown other than to say, it was not easy. However, he fought hard and has subsequently made a full recovery.

At the July 5, 2011 Town Council meeting, Officer Tracy Man and Officer Eddie McKeever were recognized by the Southern Shores Volunteer Fire Department for their lifesaving efforts and were awarded a Unit Commendation. Additionally, they each received the coveted Police Lifesaving Award for their quick response and due diligence in providing aid to Mr. Singletary. Many other emergency responders that assisted in the call were also recognized and Mr. Singletary was on hand to witness the presentation of the awards.

Southern Shores is proud to have two fine officers such as Officers Mann and McKeever. These are the moments that we, as emergency responders, strive for when we can truly do something good and know that we helped to make a difference. We offer sincere thanks to these officers and also wish Mr. Singletary success in his continuing recovery.

## LOW SPEED VEHICLES

### § 20-121.1. Operation of a low-speed vehicle on certain roadways.



The operation of a low-speed vehicle is authorized with the following restrictions:

- (1) A low-speed vehicle may be operated only on streets and highways where the posted speed limit is 35 miles per hour or less. This does not prohibit a low-speed vehicle from crossing a road or street at an intersection where the road or street being crossed has a posted speed limit of more than 35 miles per hour.
- (2) A low-speed vehicle shall be equipped with headlamps, stop lamps, turn signal lamps, tail lamps, reflex reflectors, parking brakes, rearview mirrors, windshields, windshield wipers, speedometer, seat belts, and a vehicle identification number.
- (3) A low-speed vehicle shall be registered and insured in accordance with G.S. 20-50 and G.S. 20-309.
- (4) The Department of Transportation may prohibit the operation of low-speed vehicles on any road or highway if it determines that the prohibition is necessary in the interest of safety.
- (5) Low-speed vehicles must comply with the safety standards in 49 C.F.R. § 571.500. (2001-356, s. 5.)



A golf cart is **NOT** a low speed vehicle. A low speed vehicle **MUST** be registered with the Department of Motor Vehicles. Golf carts may **NOT** be driven on any public roadway!
