Continuing Education...

In order to become a police officer in North Carolina, one must successfully complete Basic Law Enforce-**Training** ment BLET. The **BLET** Curriculum designed to prepare entry -level individuals with cognitive physical skills needed to become certified law enforcement officers in North Carolina.

The course is comprised of 36 separate blocks of instruction to include topics such as Firearms, Driver Training, Motor Vehicle Law, and Arrest, Search and Seizure. The BLET course is filled with practical exercises and an extensive ethics section that is woven throughout the training experience.

The BLET course has been thoroughly researched, legally reviewed and contains the most current law enforcement information available. The Commission mandated 620-hour course takes approximately 16 weeks to complete and concludes with a comprehensive written exam and skills testing.

Upon successful completion of the BLET State Comprehensive

Written Examination, the BLET trainee has one year from the date of the State Comprehensive Examination to be duly appointed and sworn as a law enforcement officer in North Carolina. However, most agencies include an additional period of field training.

However, law enforcement is not a static field as the law, equipment and techniques are always changing. Therefore, law enforcement officers, to be truly effective in their job can never stop learning or training.

The Criminal Justice Education and Training Standards Commission requires that every law enforcement officer certified by the Criminal Justice Education Training Standards Commission must receive a minimum of 24 hours of in -service training annually. The Southern Shores Police Department goes well above this requirement by completing the state mandated classes as well as several classes that are mandated annually by the department. Such topics include Firearms Training and Qualifications, Taser, Hazardous Materials, Bloodborne Pathogens, and Legal Updates.

The North Carolina Justice Academy offers this training in addition to a wide variety of other training opportunities for law enforcement officers to hone and expand their skill set. However, many of these training opportunities are not offered locally to Dare County. As such, many officers become trained as certified law enforcement instructors to teach these classes to other officers thereby affording them the opportunity and convenience of this valuable education that they may not otherwise get the chance to experience.

The Southern Shores Police Department is very lucky to have five officers that are certified as law enforcement instructors which enables us to not only offer valuable training opportunities to our department but to other departments in the area as well. With the addition of our training facility, we have been able to offer training to officers from Elizabeth City, Currituck County, Camden County and beyond.

Becoming an instructor is no easy task. It required drive, dedication and an ongoing commitment to excellence in law enforcement. For the Southern Shores Police Department to have 42% of it's force displaying this commitment speaks volumes for the value and integrity of the department and it's officers. Let us introduce you to those officers...



Lt. Jonathan M. Slegel

Lt. Slegel has been in law enforcement over 20 years with more than 3/4 of

that time being employed by the Southern Shores Police Department. During that time he has amassed a tremendous amount of training and experience which has enabled him to rise through the ranks to currently hold the position of second in command with

the department.

The Lieutenant serves as the department's in-service training coordinator. As such, he is responsible for maintaining all training records as well as arranging and scheduling training for everyone in the department as well as supervising all of the department's instructors.

Narcan Training

North Carolina Harm Reduction Coalition (NCHRC) is a national naloxone (Narcan) access advocacy leader, committed to getting naloxone into the hands of community members and law enforcement. North Carolina Harm Reduction Coalition (NCHRC) is North Carolina's only comprehensive harm reduction program. NCHRC engages in grassroots advocacy, resource development, coalition building and direct services for law enforcement and those made vulnerable by drug use, sex work, overdose, immigration status, gender, STIs, HIV and hepatitis.

Naloxone (also known as Narcan®) is a prescription medicine that reverses an opioid overdose, which can be caused by prescription analgesics (e.g., Percocet, OxyContin), and heroin. Naloxone will only reverse an opioid overdose, it does not prevent deaths caused by other drugs such as benzodiazepines (e.g.Xanax®, Klonopin® and Valium®), bath salts, cocaine, methamphetamine or alcohol. However, naloxone may also be effective for polysubstance overdoses such as a combined opioid and alcohol overdose. It cannot be used to get high and is not addictive. Naloxone is safe and effective; emergency medical professionals have used it for decades. For more detailed information, visit www.drugs.com/pro/naloxone.html

Law enforcement personnel are often the first to arrive on the scene of an overdose. Sometimes they are responding to an EMS call; and sometimes, in the course of their work, they just happen to encounter someone who has overdosed. We want to ensure that these officers have the training and the necessary tool, naloxone, to make a difference when it matters most. Many law enforcement officers are already trained in using AEDs (automated external defibrillators) or in administering CPR (cardiopulmonary resuscitation). Adding naloxone to their set of tools will help save lives.



The Southern Shores Police Department recently received this valuable Narcan training from Donnie Varnell who is retired from the North Carolina State Bureau of Investigation and is now employed with Narcan. Agent Varnell was once a deputy with the Dare County Sheriff's office and has worked closely with the agencies of Dare County for many years. Dare County is no stranger to the opioid epidemic and there have already been several cases in which Narcan has been administered. We are thankful that our officers have had the opportunity to receive this potential lifesaving training.
